Economy

- Third largest economy in Latin America, following Brazil and Mexico
- GDP of US\$ 450 billion
- Fifth position GPD per capita US\$ 9.122, after Uruguay, Chile, Panama and Costa Rica
- 46 million inhabitants.
 Fourth most populated country in the region
- 8th Largest Country

- One of the main food producers globally
- Large-scale agricultural and farm industries
- Leading exporters of soybean and its byproducts, honey, peanuts
- Main producer of fruits such as lemons, apples, berries

- Important mining wealth globally
- Third position as global lithium reserve
- Tenth place in gold reserves
- One of the first tenth silver producers

Economy - impact of COVID

- GDP contracted 9.9% year-on-year in 2020
- First quarter of 2021, the economy went up 2.5%, the first positive interannual growth after six consecutive months of reductions
- Exports accounted for US\$ 35.4 billion on the first half of 2021
- Highest export value in eight years

- Top partners: Brazil, China & USA
- 28,1% of the exports landed on those countries
- 49,5% of the imports came from those countries


